Bradley Chapin's practice is diverse and touches on a variety of industries and practice areas, including complex business disputes involving trade secret theft, fraud, breach of contract, business interference claims, product liability, tax shelter fraud, securities fraud, copyright and trademark infringement, civil embezzlement, defamation, real property, commercial landlord-tenant contracts and relationships, and construction contracting and defects. Brad also has extensive experience defending consumer class actions, as well as assisting clients with product recalls. Brad's practice includes representing large national companies located in and outside of California, as well as local businesses and business owners in the Orange County community. He practices in both State and Federal Courts, has successfully tried jury cases in California and Arizona.

Not long ago, Brad completed three jury trials in a twelve month period in which he headed up trial teams in all three cases that resulted in complete jury verdict wins for his clients. These cases ranged from defending a local sewing manufacturer against claims of business interference and defamation, defending a successful group of local insurance brokers that split from their former company and were sued for, among other business torts, trade secret misappropriation and officer breach of fiduciary duty, and most recently prosecuting a claim for nearly \$700,000 in unpaid invoices for a national tire distributor based in Miami and defending against product liability counterclaims for millions of dollars in damages claimed to be caused by defective tires. Each of these cases concluded with jury verdicts finding in favor of his clients.

Brad also recently completed week-long arbitration where he headed up a trial team that successfully defended one of America's leading homebuilders and a Fortune 500 company. The dispute involved two former executives who sued for over \$10 million for damages based on allegations of breach of contract and fraud. A former California Supreme Court Justice presided over the matter that resulted in a complete defense award and an order that Rutan & Tucker's client be reimbursed all of its fees litigating the case.

The arbitration was presided over by a former California Supreme Court Justice, who issued a final award finding entirely in favor of Rutan & Tucker's client and ordering that it be reimbursed all of its fees and costs. The parallel Superior Court action ended less than a year later when summary judgment was entered in favor of Rutan & Tucker's client.
- Representation of multiple national tire distributors for collection of unpaid invoices and in defense of multi-million dollar product liability claims, resulting in a 2016 jury verdict in Santa Cruz County, Arizona in favor of Mr. Chapin's Miami-based tire distributor client.
