Thai Phan is a municipal law attorney whose practice centers on providing advice and counsel to local agency clients throughout Southern California. In addition to helping her city clients with day-to-day legal operations, Thai is an advocate for her clients in civil litigation and transactional negotiations. She currently serves as City Attorney for the City of Duarte and the Assistant City Attorney for the City of Menifee. She previously served as the interim Assistant City Attorney for the City of Irvine.

As a municipal law attorney, Thai assists her public agency clients in all aspects of government. She interprets and helps her clients understand and implement state and federal laws, including the Public Records Act, the Brown Act, the California Environmental Quality Act, First Amendment and free speech rights, elections law, and land use and zoning laws. Providing advice related to the Political Reform Act and Fair Political Practices Commission regulations also comprises a large part of her practice, particularly as it relates to potential conflicts of interests for elected and appointed officials. Thai also prepares ordinances, resolutions, and staff reports on behalf of her clients.

Thai has litigation experience in municipal code enforcement, municipal defense and prosecution in section 1085 and section 1094.5 writ actions, *Pitchess* defense, the Government Claims Act, eminent domain, as well as general civil litigation. Some examples of litigation matters include assisting in the successful prosecution of a breach of contract by a member of a joint powers authority resulting in a major victory for the authority and assisting in eminent domain proceeding resulting in success for a city.

Thai also drafts and negotiates agreements with private contractors on behalf of local municipalities as a part of her transactional practice.
